## A copy of last year's tax return.

- Photo ID
- Bank Account Information
- Social security numbers for the taxpayer, spouse, and any children in the household born before December 31, 2014 are needed to claim the EIC.
- W-2 forms from all 2014 jobs.
- 1095A Form, Health Insurance Marketplace Statement
- 1099-G Form, if you received unemployment insurance benefits at any time in 2014.
- 1099INT, if you received bank interest in 2014 or any statements received from a mortgage company during 2014.
- Workers with Individual Taxpayer Identification Numbers should bring the ITIN card sent to them by the IRS. Workers need either an ITIN or an SSN for the Child Tax Credit.
- W-2 G Gambling Income

IF YOU OWN YOUR HOME: Please bring your 2014 (Homestead) Property Tax Statement. (You receive yearly from the County Treasurer's Office in a blue envelope.)

Tax preparers **WILL**  
**NOT** prepare complex  
returns involving: farm,  
business, or investment  
income.

Difficulty of return is left to the  
discretion of the tax preparer.

**Save \$80 -- \$300**  
***In tax preparation fees***

ALL returns will be E-filed unless a  
condition requires it to be mailed.

Past year returns can be prepared in  
March and April.

## Do You Qualify for Earned Income Credit?

If you are between the ages of 25 and 64 or have a minor dependent, you may qualify for Earned Income Credit.

In order to be eligible for the Earned Income Credit, you must have earned income from employment or from self-employment.

Your income must be less than:

- \$14,590 (\$20,020 married filing jointly) with no qualifying children
- \$38,511 (\$43,941 married filing jointly) with one qualifying child
- \$43,756 (\$49,186 married filing jointly) with two qualifying children
- \$46,997 (\$52,427 married filing jointly) with three or more qualifying children
